Both the parties are absent without steps.

Today is fixed for passing no dispute award in view of order no. 38 dt. 28.11.2024.

Case record is taken up for passing order.

This case has been filed by the applicant/workman Sri Nabarun Mondal under Section 2A(2) of the Industrial Disputes Act, 1947 against his employer M/s Axis Three Dee Studios Pvt. Ltd., in connection with termination of service of the applicant illegally with a prayer to reinstate him in service with full back wages and other consequential benefits.

Perused the case record wherefrom it appears that since 08.10.2021 the applicant is absent and on 30.11.2021 a show cause notice was issued upon him directing him to file reply to show cause on 10.01.2022 as to why no dispute award shall not be passed in the instant case. Thereafter, a fresh show cause notice was issued on

23.02.2023 upon the applicant directing him to file reply to show cause on 13.04.2023 as to why no dispute award shall not be passed in the instant case.

It appears from the case record that since 13.04.2023 till 14.05.2024 (on five dates) the Ld. Advocate for the applicant appeared and prayed for adjournments and did not file any reply to the show cause. It furthermore appears from the order sheets that since 29.07.2024 the Ld. Advocate for applicant also did not appear and no reply to show cause has been filed by the applicant till date in compliance of the order dated 30.11.2021 and hence, it appears from the conduct of the applicant that the applicant is not interested to proceed with the case.

In view of the aforesaid conduct of the applicant, this Tribunal holds that no industrial disputes exist in between the parties. So, I am inclined to pass a 'No Dispute' Award on the footings that Industrial Disputes under Rule 22 under West Bengal Industrial Dispute Rules, 1958 is no longer in existence.

Hence, it is

Ordered

that the case being No. 46 of 2019 u/S 2A(2) of the Industrial Disputes Act, 1947 be and the same is dismissed for non existence of any Industrial Dispute. This is to be treated as 'No Dispute Award'.

This is my award.
