Both the parties are absent without steps.

Today is fixed for passing no dispute award in view of order no. 75 dt. 12.12.2024.

Case record is taken up for passing order.

This case has been filed by the applicant/workman Sri Somnath Adhikary under Section 2A(2) of the Industrial Disputes Act, 1947 against his employer M/s India Infoline Finance Limited in connection with termination of service of the applicant illegally with a prayer to reinstate him in service with full back wages and other consequential benefits.

Perused the case record wherefrom it appears that on 10.12.2021 a show cause notice was issued upon the applicant directing to file reply to show cause on 21.01.2022 as to why no dispute award shall not be passed in the instant case.

Due to non appearance of the applicant since long, on 15.02.2023 and thereafter on 05.03.2024 notices were issued upon the applicant directing him to appear on 16.04.2024 and file reply to show cause as to why no dispute award shall not be passed in the instant case. Thereafter, due to repeated non

appearance of the applicant, vide order dated 23.08.2024 a fresh notice was issued upon the applicant directing him to appear on 22.11.2024 and file reply to show cause as to why no dispute award shall not be passed in the instant case. Thereafter, from order dated 29.11.2024 it appears that This Tribunal observed that from the postal track report that the notice sent to the applicant was delivered with the postal remark 'Item Delivered'. The applicant was absent on that day also on repeated calls. Therefore, for the ends of justice, he was given an opportunity to appear before this Tribunal and to file reply to show cause on 12.12.2024, but despite that, none appeared for the applicant on repeated calls on that day too and no reply to show cause has also been filed from the side of the applicant. Therefore, it appears that the applicant is not interested to proceed with his present case further.

In view of the aforesaid conduct of the applicant, this Tribunal holds that no industrial disputes exist in between the parties. So, I am inclined to pass a 'No Dispute' Award on the footings that Industrial Disputes under Rule 22 under West Bengal Industrial Dispute Rules, 1958 is no longer in existence.

Hence, it is

Ordered

that the case being No. 12 of 2015 u/S 2A(2) of the Industrial Disputes Act, 1947 be and the same is dismissed for non existence of any Industrial Dispute. This is to be treated as 'No Dispute Award '.

This is my award.
