Today is the date fixed for evidence on behalf of the Workman.

This First Industrial Tribunal is lying vacant since 02.01.2024 due to non appointment of any Regular Presiding Officer.

Learned Judge, Fourth Industrial Tribunal is in charge of First Industrial Tribunal and is ready for regular hearing of the cases in view of the Labour Department's Notification dated 19.11.2024.

The workman himself is present along with his Representative Ld. Counsel.

The Representative of the OP/Company is present along with Ld. Counsel.

A joint petition has been filed along with a Memorandum of Settlement by both the parties praying for disposal of this case on consent in terms of the said Memorandum of Settlement.

The Workman, Sri Saumen Saha is accordingly examined as PW-1 and discharged.

Having heard the submissions of the both sides Ld. Counsel and on perusal of their joint petition and the aforesaid Memorandum of Settlement coupled with the evidence of the workman, Sri Saumen Saha admittedly it appears that as regarded the dispute between the parties a settlement has arrived at between them resulting which the aforesaid Memorandum of Settlement executed by them by putting their signatures.

The workman in his evidence admitted that in terms of their Memorandum of Settlement he has got a draft of Rs. 2,00,000/- (Rupees two lakh) and cash of Rs. 25,000/- (Rupees twenty five thousand) only today from the OP/Company namely M/s Nicco Park & Resorts Private Limited.

Having considered the facts and circumstances when it appears that the terms and conditions as embodied in the Memorandum of Settlement are valid, legal and satisfactory then the same is accepted, and I find nothing convincing to stand in the way of the prayer of both parties regarding passing of Award in terms of the said Memorandum of amicable settlement of dispute.

The Memorandum of Settlement is considered and accepted being genuine one and voluntary without any provocation, undue influence or coercion from any corner.

After hearing both sides it is

AWARDED

In pursuance of the observations made above, the instant case No. **05 of 2015 u/s 10(1B)(d)** is disposed of on the basis of Memorandum of Settlement dated 20.12.2024 and considering all aspects and having heard the Ld. Counsel for the Company and the Workman himself the prayer made in Memorandum of Settlement is allowed and AWARD accordingly is being passed on the basis of terms and conditions of the said Memorandum of Settlement, which be made part of this AWARD.

Thus the instant case is disposed of.

This is my AWARD.






