WHEREAS under reference of Labour Department's Order No. Labr./517/(LC-IR)/22015(16)/328/2018 dated 18.07.2018 the Industrial Dispute between M/s. Kingsley Industries Ltd., 7, Chittaranjan Avenue, Kolkata – 700072 and its workman Sri Dhananjoy Kumar Singh, 8, Chittaranjan Avenue, Kolkata – 700002 regarding the issues mentioned in the said order, being a matter specified in the Second Schedule to the Industrial Dispute Act, 1947 (14 of 1947), was referred for adjudication to the Eighth Industrial Tribunal, Kolkata.

An industrial dispute between M/s. Kingsley Industries Ltd., 7, Chittaranjan Avenue, Kolkata - 700072 and its workman Sri Dhananjoy Kumar Singh, 8, Chittaranjan Avenue, Kolkata - 700002 Vide G. O. No. Labr./517/(LC-IR)/22015(16)/328/2018 dated 18/07/2018 and reference no. 3115-IR/IR/3A-6/59, dated 21/06/1960 referred to this Tribunal for adjudication.

The said Seventh Industrial Tribunal shall submit its award to the State Government within a period of three months from the date of receipt of this order by the said Seventh Industrial Tribunal in terms of Sub-section (2A) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947), subject to the other provision or provisions of the said Act.

The said Seventh Industrial Tribunal shall meet at such places and on such dates as it may direct.

I S S U E (S)

1. Whether the termination of service of Sri Dhananjoy Kumar Singh, w.e.f. 01.07.2016 by the management of M/s. Kingsley Industries Ltd. is justified ?
2. To what relief, if any, is he entitled ?

In view of G.O. No. Labr./700/(LC-IR)/23099/15/2019 dated 26.07.2019 this case has been withdrawn from the file of Seventh Industrial Tribunal and has been transferred to this Tribunal i.e. Eighth Industrial Tribunal, Kolkata for disposal.

The case record is taken up for passing order.

On scrutiny of the entire record I find that Dhananjoy Kumar Singh the applicant was examined as P.W.-1 on 05.03.2021 and his examination-in-chief was deferred on verbal prayer of the Ld. Advocate for the applicant. It also appears that after remaining vacant this Court for a long period after joining the regular P.O. although Ld. Advocate for the management M/s. Kingsley Industries Ltd. was present, neither workman nor his Ld. Advocate appeared before the Court. Then from 25.05.2024 in spite of issuance of show cause notice to the workman for several times directing for appearance and S/R of the workman, none appeared on behalf of the workman nor any S/R was received.

Therefore, it is crystal clear from the above conduct of the workman that he is not interested to proceed with the instant case any further. In view of the aforesaid conduct of the workman Sri Dhananjoy Kumar Singh this Tribunal has no hesitation to hold that there is no dispute exists at present between the parties and as such the case is liable to be disposed off in view of Rule 22 of the West Bengal Industrial Dispute Rule, 1958.

Hence, it is

ORDERED

that the industrial dispute being No. VIII-19 of 2018 of the Industrial Disputes Act, 1947 under

reference no. 3115-IR/IR/3A-6/59, dated 21/06/1960 and also vide reference order no. abr./517/(LC-IR) /22015(16)/328/2018 dated 18/07/2018 is no longer in-existence and accordingly the case is disposed off and this order is to be treated as No Dispute Award between the parties.
