AWARD

Dated: 15th July, 2025.

This purported industrial dispute existing between M/s Calcutta Pinjrapole Society, 34 Armenian Street, Calcutta -700 01 and their workman Smt. Puspa Seal, 4, Karuna Pukur Road, P.O. – Belur Math, Howrah – 711202.

That on 20.02.2012, OP/Company filed a petition praying for holding the instant application u/s 2A(2) filed by the applicant/workman as without territorial jurisdiction. Against which the applicant/workman has filed a Written Objection on 27.03.2012.

After hearing the petition dated 20.02.2012 and Written Objection dated 27.03.2012 this Tribunal passed an order vide Order No. 14 dated 19.04.2012 that the instant application has been filed with proper territorial jurisdiction and the instant prayer for holding the application as without territorial jurisdiction, stands refused.

Against the Order No. 14 dated 19.04.2012 of this Tribunal the Petitioner/Company filed Writ application vide W.P.O. No. 13883(W) of 2012 before the Hon'ble High Court, Calcutta, copy of which has duly been submitted before this Tribunal along with Advocate's letter dated 29.06.2012 on 02.07.2012.

Since then the instant case was fixed for awaiting order from the Hon'ble High Court at Calcutta in respect of W.P.O. No. 13883(W) of 2012 and most of the time parties to this instant case were absent without taking any steps and very reluctant to appear before this Tribunal.

That on 24.06.2025 the instant case was fixed for appearance of the parties and taking steps by the parties, particularly furnishing information regarding the present status of the W.P.O. No. 13883(W) of 2012 and awaiting further order of the Hon'ble High Court at Calcutta in respect of the W.P.O. No. 13883(W) of 2012 and on suomoto, searching of the website of High Court, Calcutta in respect of the present status of the Writ Petition No. 13883(W) of 2012, it was revealed that it was disposed of on 23.04.2024 by the order of dismissal of the WPA for default. It was also ordered by the Hon'ble Court that interim order, if any, stand vacated. So, keeping in mind the above order of the Hon'ble High Court, I find there is no other impediment to dispose of this case at its own motion.

However, considering the above conduct of the parties to this case that they are not appearing and participating in the proceeding of this case for a long period without taking any steps, there is sufficient ground to presume that no such industrial dispute is in existence between the parties at this stage. And the date 15.07.2025 was fixed for appearance of the parties and taking steps by them particularly by the applicant/workman, failing which necessary order to the effect that no industrial dispute is in existence will be passed.

That on 15.07.2025 both the parties to this case are absent without taking any step.

So, considering such conduct of the parties to this case particularly of the applicant/workman, it is clearly established that none of them are interested to proceed with this case, which gives rise to presume that no such industrial dispute is in existence between the parties.

Hence it is

ORDERED

That there is no industrial dispute is in existence between parties.

This is my Award.
