This industrial dispute has been referred, by the Government of West Bengal between Rajhans Restaurant & Hotel Pvt. Ltd. of Nainan, Falta, Sector-IV, South 24 Parganas and their Workmen represented by Hotel Rajhans Workers Union, Falta Export Processing Zone, Sector-IV, South 24 Parganas for adjudication of the matter on the following issues and submitting its award to the State Government.

ISSUES

- 1) Whether the suspension of work declared by the management of Rajhans Restaurant & Hotel Pvt. Ltd. for the period from 08.09.2005 to 07.01.2006 is justified?
- 2) What relief, if any, are the Workmen entitled to?
- Whether the management is justified in refusing employment to as many as 20 (twenty) permanent workmen (as per list enclosed) w.e.f. 08.01.2006?
- Whether the management is justified in not paying service charges to 20 (twenty) permanent workmen w.e.f. April 2005?

It is revealed from the record that after receipt of the aforesaid reference of Government of West Bengal, notices were duly issued upon the parties who appeared on 12.09.2007 and also filed their respective statement of claim and list of documents along with the documents and ultimately documents have been exchanged between the parties and thereafter



evidence was started on and from 25.09.2008 from the side of the Union and the same was closed on 21.09.2017 when the evidence of CW-1 stood expunged because of the fact that the Company after getting opportunities on number of occasions to produce CW-1 before this Tribunal but failed.

Thereafter, the record was fixed for argument on 09.11.2017 and it was allowed to continue till 11.02.2021 and lastly the case was fixed for argument on exparte since the Company did not appear till 09.03.2021.

In spite of the above facts and circumstances none of the parties specially the Union appeared even repeated service of notices asking them to appear before this Tribunal but no result was found till 29.07.2022 when the case is taken up for Award on the ground of No Dispute.

Thus, considering the above facts and circumstances coupled with the conduct of the Union this Tribunal has been forced to held that the Union being the applicant itself is not willing to proceed with the case further and therefore, this industrial dispute should be no longer in existence by and between the parties thereto.

In these circumstances a "No Dispute Award" should be passed on the footings of the present industrial dispute raised by the Union named Hotel Rajhans Workers Union which will sub-serve the interest of justice.

This is my Award.

The Award be sent to the Government immediately.
