## Order No.61, dated 30-09-2019

Case record is put up by petition filed on behalf of applicant Smt. Sikha Mallick, who is present with her Ld. Advocate.

OP/Company is also present through its Ld. Advocate.

Applicant has filed a verified petition praying for dismissal of the present case for non-prosecution on the ground stated therein. Copy served upon the OP/Company.

Another petition has been filed on behalf of the applicant by her Ld. Advocate praying for an order to examine the applicant (PW-1), on recall, on the ground stated therein. Copy served upon the OP/Company.

Petition for recall is taken up for hearing.

Heard both sides. Perused the petition for recall along with petition for dismissal of the present case for non-prosecution. Considered. Prayer is allowed.

Applicant Smt. Sikha Mallick (PW-1) is examined on recall, cross-examination is declined and discharged.

Heard Ld. Advocates for the applicant as well as OP/Company in respect of the petition for dismissal of the present case for non-prosecution. Considered.

Case record is taken up for passing order.

This is a case under Section 2A(2) of the Industrial Disputes Act, 1947, filed by the applicant Smt. Sikha Mallick, against her employer M/s. Institute of Neuro Sciences Kolkata, seeking reinstatement in service with full back wages and other consequential

benefits with the declaration that the alleged order of her termination dated 31.08.2011 is unjust, improper and illegal.

Perused the present petition for dismissal for non-prosecution along with the evidence of PW-1, recorded today, and materials available on record. Also perused the photocopies of agreement dated 30.09.2019, executed between the parties, and demand draft of Rs.1,53,600/- (Rupees one lakh fifty-three thousand & six hundred only) dated 20.09.2019, issued in the name of the applicant Smt. Sikha Mallick, so annexed with the present petition for dismissal of this case. During her evidence, recorded today, PW-1 has clearly stated that the matter in dispute in between the OP/Company and her has already been settled out of Court by executing an agreement dated 30.09.2019 and she has received a demand draft of Rs.1,53,600/- (Rupees one lakh fifty-three thousand & six hundred only) and further stated that she has no allegation against the OP/Company and she has also no claim against the said company and so, she does not want to proceed with the case further. She has also stated that she has filed a petition today to that effect with a prayer for dismissal of the case for non-prosecution and she has identified her said petition, duly signed by her. She has clearly prayed for dismissal of the case for non-prosecution. Therefore, from her above evidence, it is clear that the matter in dispute in between the parties has already been settled amicably out of this Tribunal and so, the applicant does not want to proceed with this case further and has prayed for dismissal of the present case for non-prosecution. Considering all aspects as well as above referred evidence of PW-1, I am of the view that the prayer of the applicant for dismissal of the case should be allowed.

Hence, it is,

### ORDERED

that the Case being No. 41 of 2012 under Section 2A(2) of the Industrial Disputes Act, 1947 be and the same is dismissed for non-prosecution.

The petition for dismissal of the case for non-prosecution, filed today, by the applicant Smt. Sikha Mallick, be made part of this order.

The case record need not be put up on the date already fixed i.e. on 21.11.2019.

This is my AWARD.
