MEMORANDUM

Whereas, in terms of Labour Department's G.O.634-G.E. Dt.25.03.2010 read with the approval of Finance Department vide their U.O. 656 Group P(Service) Dated 19.02.2010 and subsequent approval of the Cabinet vide no.1816 Dt.18.03.2010, Four Hundred & Eighty (480) contractual posts of Clerk with Knowledge of Computer operation (CKCO) were created, and

Whereas 480 nos. of CKCOs were appointed through a prescribed method as laid down in the Order No.2295-GE Dt.06.07.2010 read with Letter no.LS-215/2010 Dt.19.07.2010 issued in the light of Finance Department's U.O.656 Gr.(P) Dt.19.02.2010, and

Whereas, the CKCOs were engaged at the 480 Labour Welfare Facilitation Centres (LWFC) in different Blocks, Municipalities, Corporation areas and DGHC area for strengthening the machinery in order to implement various Labour Welfare programmes under the administrative control of this Department, and

Whereas, the matter of bringing the existing CKCOs under the purview of F.D. Memo. No.9008-F(P) Dt.16/09/2011 and subsequent Orders issued thereon was under active consideration of the Department for some time past, and

Whereas 341 (Three Hundred Forty-One) CKCOs were in position till 17/10/2023, and out of them 246 (Two Hundred & Forty-Six) nos. of CKCOs had rendered 10 years of service continuously with at least 240 days attendance in each year, and

Whereas, after careful consideration, necessary checks and balances and in concurrence of the Finance Department vide their U.O. No: Group P2/2023-2024/0516, Dt.22/08/2023, the Governor, vide this Department's Memorandum No. Labr/958/(LC-Estt) Dt.17.10.2023, was pleased to allow:

- i. Similar benefits as contained in Finance Department Memo. No.9008-F(P) Dt.16/09/2011 and subsequent orders issued thereon in favour of those 246 nos. of Clerk with Knowledge of Computer (CKCOs) who had rendered 10 years of service continuously with at least 240 days attendance each year, with effect from 1st September, 2023, and
- ii. 3% enhancement of remuneration on first July of every year to the CKCOs as noted immediately above, [As per Finance (Audit) Memo. No. 1107-F(P), Dt. 25/02/2016], and

Whereas, the Memorandum No. Labr/958/(LC-Estt) Dt.17.10.2023 of this Department, issued in favour of 246 CKCOs, was cancelled vide this Department's Memorandum No. Labr/1033/(LC-Estt.) Dt.24/11/2023 considering the order passed by Hon'ble High Court on 16.10.2023 in WPA 16840 of 2023 in the matter of Rahul Chandra Khamari & 14 Ors. Vs. The State of West Bengal & Ors., and

Whereas, the matter arising out of WPA 16840 of 2023 in the matter of Rahul Chandra Khamari & 14 others Vs. The State of West Bengal & Ors has not yet been concluded, as a recalling application has been filed against the order Dt.01.08.2025 passed by the Division Bench of Hon'ble High Court in MAT No.1605 of 2024, and

Whereas, out of the total 246 eligible CKCOs who were previously brought under the purview of Memo.9008-F(P) Dt.16.09.2011 in terms of this Department's Memorandum Labr. /958/(LC-Estt) Dt.17.10.2023, Six (06) CKCOs subsequently resigned, and four (04) others have completed 10 years of continuous service at a later stage and accordingly, the present number of eligible existing CKCOs stands at 244, and

Whereas, the Finance Department has categorically stated that no petitioner CKCO shall come under purview of Memo.9008-F(P) Dt.16.09.2011 till disposal of the original court case bearing no. WPA 16840 of 2023 in the matter of Rahul Chandra Khamari & 14 Ors. Vs. The State of West Bengal & Ors in the appeal and in the recalling application arising out of MAT No.1605 of 2024 read with WPA 16840 of 2023, and

Whereas, out of the 15 petitioners in case bearing no. WPA 16840 of 2023, only eight CKCOs have completed 10 years of continuous service with at least 240 days attendance in each year,

Therefore, the Governor is pleased to extend the following benefits to the eligible existing 236 CKCOs who agreed to have benefits in line with Finance Department's concurrence and have already submitted their undertakings (a list of 236 eligible CKCOs enclosed and marked with "Annexure- A"):

- i. Similar benefits as contained in Finance Department Memo. No.9008-F(P) Dt.16/09/2011 and subsequent orders issued thereon, with effect from 01/09/2023, and
- ii. Benefits of Memo No. 1091- F(P2) dated 1.3.2024 as applicable.

The Governor is further pleased not to extend above benefits to the petitioners (8 nos.) connected with WPA 16840 of 2023, who have rendered 10 years of continuous service with at least 240 days attendance in each year till final disposal of MAT No.1605 of 2024 read with WPA 16840 of 2023.

The four (04) CKCOs who completed 10 years of service after 01.09.2023 shall receive the benefit from the day immediately following the date on which they completed 10 years of service.

The benefits under Memo No. 9008-F(P) dated 16.09.2011 and the subsequent orders issued thereon shall be admissible only to those CKCOs who satisfy the eligibility norms and conditions prescribed therein.

The Government shall, however, remain at liberty to withdraw such benefit and recover any over payments if it is subsequently found that any CKCO is not entitled to such benefit.

The matter relating to the petitioner CKCOs (out 15 petitioners, only 8 have completed 10 years of service) shall be taken up again after the final decision of Hon'ble Court in the appeal and the recalling application arising out of MAT No.1604 of 2024, which itself arises out of WPA 16840 of 2023.

The O.S.D. & Ex-Officio Labour Commissioner, West Bengal, being the appointing authority of the CKCOs, is hereby authorized to take all necessary measures for giving effect to the above benefits, by issuing appropriate orders or otherwise ensuring that no ineligible CKCO receives any benefit mentioned hereinabove, and to maintain a proper Record Manual in respect of each existing CKCO.

The matter of extending similar benefits under Memo No. 9008-F(P) dated 16.09.2011 and the subsequent orders issued thereon to the remaining CKCOs who are presently in position and rendering service for at least 240 days in each year, but have not yet completed 10 years of continuous service, shall be examined in due course as and when they complete the requisite period of 10 years. Until such time, the consolidated remuneration, yearly enhancement of remuneration, and other service conditions

applicable to such CKCOs shall remain unchanged. However, extending similar benefits under Memo No. 9008-F(P) dated 16.09.2011 and the subsequent orders issued thereon to the rest seven petitioners who have not completed 10 years of service till date will be taken up only after the final disposal of MAT No.1605 of 2024 read with WPA 16840 of 2023 and on fulfilment of prescribed criteria.

This issues in concurrence with the Finance Department vide UO No.: Group P2/2025-2026/0767 Date: 20/11/2025.
