NOTIFICATION

Whereas, the Governor was pleased to exempt the establishment namely, M/s. CRI Limited (formerly unit national cash register), 4-D Dalhousie square East, kol-1 against the PF code No . WB/5010 vide notification No. 1601-P.F/PF-14-9/64 dt 20.04.1964 under section 17(1)(a) of the Employees' Provident Fund & Miscellaneous Provisions Act, 1952 from the operation of all provision s of the said Act of Employees' Provident Fund Scheme, 1952, subject to the conditions specified therein .

Whereas, it has been reported by the Addl. Central P.F. Commissioner (Exemption) vide No . EXEM/10(99)/2018/5010/WB Date. 19.01.2023 that

- i. The board of Trustees on 11.02.2020 unanimously passed a resolution to surrender exemption w.e.f 01.06.2020.
- ii. The applicatio n of the establishment for surrender of Exemption was placed before the Exempted Establishment Committee of the Central Board, in their 51st meeting held on 18.10.2022 and subsequently to the 232nd meeting of the Central Board of Trustees, held on 31.10.2022 & 01.11.2022.
- iii. The establishment has furnished the third party Audit Report for the financial year 2019-20 & 2020-21(up to 31.05.2020)
- iv. The Central Board of Trustees has recommended the acceptancecf Surrender application of M/s. CRI Limited (formerly unit national cash register), WB/5010 for a formal cancellation of exemption under section 17(4) of EPF & MP Act, 1952.

And whereas the Jurisdictional Regional Provident Fund Commissioner, Kolkata has also reported that the establishment has started reporting compliance to EPFO as unexempted establishment with effect from 01.06.2020 and all the securities along with past accumulation of the members lying in the P F Trust has also been transferred in the name of Central Board of Trustees, EPF.

And whereas Central EPFO has requested to consider for issuance of necessary formal order regarding cancellation of exemption in respect of the said establishment.

After considering the proposal of EPFO authority and the correspondences, documents, it may be deduced that M/s CRI Limited (formerly unit national cash register) 4-D, Dalhousie square East, kol- 1 has Surrender exemption and act as unexempted establishment, the recommendation of cancellation from the EPFO authority seems to be appropriate and valid.

Now, the Governor is hereby pleased to cancel the exemption of the M/s CRI Limited (formerly unit national cash register) 4-D Dalhousie square East, kol-1 against the EPF code WB/5010 vide Notification No- 1601-P.F/P.F-14- 9/64 Dt. 20.04.1964 as per section 17(4) of the Employees Provident fund Miscellaneous Provisions Act, 1952 and as per section 27 of the Employees Provident fund Scheme 1952, from the date of issuance of the notification.
